URBAN BARZ

ARTIST LICENCE AGREEMENT (2026)

This Artist Licence Agreement (the "Agreement") is entered into between Tamara Jenna Productions Ltd ("TJPL") and the submitting Artist (the "Artist").

DEFINITIONS

"**Track**" means the audio recording submitted by the Artist.

"**Compilation**" means Urban Barz and any TJPL Music Global compilation, whether now existing or created in the future, including subsequent volumes, spin-offs, or themed editions.

"**Clean Version**" means a radio-friendly, non-explicit version of the Track.

"**Territory**" means worldwide.

"**Media**" includes all digital, editorial, promotional, broadcast, and physical formats.

"**Net Revenue**" means gross revenue received by TJPL less platform, manufacturing, payment processing, and fulfilment fees.

GRANT OF LICENCE

The Artist grants TJPL a non-exclusive, worldwide, revocable licence to reproduce, distribute, upload, promote, manufacture, sell, and communicate the Track as part of the Compilation. The Artist retains 100% ownership and copyright of the Track.

USE ACROSS COMPILATIONS

The Artist acknowledges and agrees that TJPL may include, reuse, and promote the Track across any Urban Barz or TJPL Music Global compilations, whether now existing or created in the future. Such use remains non-exclusive and subject to the same ownership, revenue-sharing, and royalty terms set out in this Agreement.

LIKENESS, IMAGE & ARTWORK USAGE

The Artist grants TJPL a non-exclusive, worldwide, royalty-free licence to use their name, likeness, approved images, branding, artwork, and biography for promotional materials, packaging, editorial content, social content, playlists, and press relating to the Compilation and any associated TJPL Music Global releases.

CLEAN / RADIO-FRIENDLY REQUIREMENT

The submitted Track must be a Clean Version without explicit content. Tracks unable to supply a Clean Version may be removed.

REVENUE SHARING — 50/50 MODEL (DIGITAL + PHYSICAL)

All revenue generated from the Compilation is collected by TJPL via Bandcamp and other authorised sales or distribution platforms.

Individual Track Sales (Digital)

- 50% of Net Revenue attributable to the Track is payable to the Artist.
- 50% is retained by TJPL.

Full Album Purchases (Digital)

- 50% retained by TJPL.
- 50% shared equally among all tracks.

With fifteen (15) tracks: each track receives 3.33% of Net Revenue.

Physical Copies (Short-Run)

A limited physical run of up to one hundred (100) copies may be produced. Physical copies may be sold via Bandcamp, tjplnews.com, TikTok, direct-to-fan channels, and other outlets at TJPL's discretion. The Compilation may also be sold or distributed elsewhere.

After manufacturing and fulfilment deductions: 50% retained by TJPL and 50% shared equally per track.

ROYALTY PAYMENTS & THRESHOLD

Artist royalties are paid by TJPL, not by Bandcamp or third-party platforms. Payments are issued quarterly in January, April, July, and October, following accounting reconciliation for the preceding period. A minimum payout threshold of **£20 GBP** applies. Balances below this threshold will roll over to the next payment period until the threshold is met.

NO RECOUPMENT

Artist royalties are non-recoupable and will not be reduced by TJPL operating or production costs.

PHYSICAL CD POLICY

Artists do not receive free physical copies and are not required to sell or distribute physical media. TJPL handles all production, stock, pricing, and fulfilment.

WARRANTIES

The Artist warrants that they own all rights, have cleared all samples, and that the Track does not infringe third-party rights.

REMOVAL

The Artist may request removal with thirty (30) days' written notice. TJPL may remove the Track immediately if legal, contractual, or reputational risks arise.

DATA PROTECTION

TJPL complies with UK GDPR and the Data Protection Act 2018.

LIABILITY

TJPL is not liable for indirect or economic losses. Liability is capped at revenue generated from the Artist's Track in the preceding twelve (12) months.

GOVERNING LAW

This Agreement is governed by the laws of England and Wales.
